The Mariner Outreach System (MOS) was developed by the Maritime Administration (MARAD) as a service to U.S. merchant mariners who through their qualifications, job skills and experiences contribute to the overall economic interests and national security of the United States.

Mariners worldwide who have agreed to participate either through the U.S. Coast Guard's Application for License/MMD or the MOS will have an opportunity to review their U.S. Coast Guard qualifications/ sea service and update their contact information.

The MOS is important and will help MARAD understand mariners and their willingness/availability to sail during a sealift crisis.

Participation in MOS in NO way obligates a mariner to sail.

By participating in MOS, mariners will be able to view the following information from the USCG Merchant Marine Licensing and Documentation (MMLD) system:

1. Personal information (name, citizenship, date of birth).
2. Contact information (address, phone, email) on record. Provide additional up-to-date contact information including the best way we can reach you. Note: updates to your contact information do not change the information in the official USCG MMLD data base.
3. MMD information to include qualifications and expiration date.
4. License information to include qualifications and expiration date.
5. STCW information to include qualifications and expiration date.
6. Sea service on record in the official USCG MMLD database.
